APPLICABILITY:

Applicable throughout the entire territory served by the Company for private fire service furnished to residential, commercial, industrial and municipal customers, exclusively for the extinguishment of fires, subject to the terms and conditions as set forth elsewhere in this tariff.

ANNUAL RATES

The rates for Private Fire Service are based upon the size of the service, and no additional charges will be made for fire hydrants, sprinklers, hose connections or standpipes connected to or supplied by such private fire services.
