**WITHDRAWAL OF COMPLAINT**

Intrado Communications Inc. (Intrado) hereby withdraws its complaint against Qwest Corporation d/b/a CenturyLink QC (CenturyLink) filed in this docket on June 9, 2014, in its entirety, including but not limited to the request for an expedited proceeding under Iowa Code § 476.101(8) and the requests for relief set forth in the complaint.

Over the course of the complaint proceeding, Intrado has come to believe that it is in the best interest of the public safety community and the citizens of Iowa for Intrado to attempt to renew its partnership with CenturyLink for the delivery of ALI database management services in Iowa. Accordingly, Intrado has decided to withdraw its complaint in a good-faith effort to pursue a renewed partnership with CenturyLink that could allow Intrado to continue its role in delivering the same highly reliable ALI database management services Iowa has received for the past 18 years.

Pursuant to 199 IAC 7.21, Intrado respectfully requests that the Iowa Utilities Board promptly issue an order dismissing the complaint without prejudice and closing the docket without further proceedings.<sup>1</sup>
