

**72,500V MAXIMUM (69,000V NOMINAL) Electric Transmission Line
Hiawatha to Lafayette 69kV
Linn County, Iowa**

This proposed electric transmission line will begin on private right of way at a point of electrical connection within Interstate Power and Light Company's (IP&L) Lafayette Substation at a point near the west margin of public right of way near the intersection of County Road E28 (a.k.a. Roosevelt Street) and East Otter Road, located in the Northwest Quarter of the Northwest Quarter of Section 28, Township 85 North, Range 7 West of the 5th Principal Meridian, Linn County, Iowa; thence south-southwesterly on private right of way adjacent to the said west margin of public right of way of County Road E28 to a point approximately .14 mile south-southwesterly of said IP&L's Lafayette Substation; thence northwesterly on private right of way adjacent to the north margin of a private drive, to a point in the Northeast Quarter of the Southeast Quarter of the Northeast Quarter of Section 29, said township and range, a distance of approximately .22 mile; thence west-southwesterly on private right of way to a point in the Northwest Quarter of the Southeast Quarter of the Northeast Quarter of said Section 29, a distance of .11 mile; thence southerly on private right of way and crossing the public right of way of said County Road E28 to a point on private right of way on the east side of the Cedar Valley Nature Trail in the Southeast Quarter of the Northeast Quarter of said Section 29, a distance of approximately .09 mile; thence south-southeasterly on the private right of way on the east side of the Cedar Valley Nature Trail across the East Half of Section 29, the East Half of Section 32 and the Southwest Quarter of the Southwest Quarter of Section 33, all in said township and range, a distance of 1.58 miles. The distance of this segment of line is approximately 2.14 miles.

This proposed electric transmission line will also begin on private right of way on the east side of the Cedar Valley Nature Trail at a point of electrical connection with petitioner's transmission line near the northeast corner of Section 5, Township 84 North, Range 7 West of the 5th Principal Meridian, Linn County, Iowa; thence south-southeasterly on private right of way on the east side of the Cedar Valley Nature Trail across the Northeast Quarter of the Northeast Quarter of said Section 5, the West Half of Sections 4, 9 and 16, all in said township and range, and crossing the public rights of way of Midway Road and County Home Road, to a point on the north corporate limits of Robins, Iowa, approximately .19 mile west of the north-south centerline of said Section 16, a distance of approximately 2.79 miles. The distance of this segment of line is approximately 2.79 miles.

The total distance of this line is approximately 4.93 miles.
