Dear Ms. Conrad:

Please find submitted to the Iowa Utilities Board (IUB) today via EFS, confidential Revised Attachment A, of Interstate Power and Light Company's (IPL) Emissions Plan and Budget Periodic Report, initially filed with the IUB on March 31, 2015. IPL noticed that information in the table titled "2013-2017" on page 8 of Attachment A did not correctly match information in the table titled "IPL SUMMARY - CAPITAL AND O&M COSTS BY PLANT (IPL Share)" on page 1 of Attachment A. In addition, on page 8 of Attachment A, IPL noticed that it had not included actual and projected expenses for the Allowance Cost line item. This table has been updated and footnoted with these expense data. The title of the table on page 8 has also been revised to "Section II Summary".

Further, IPL has made revisions to the table titled "Interstate Power & Light Emissions Allowance Forecast" on page 9 of Attachment A. This table is now titled "Interstate Power & Light Emissions Allowance Purchases" to better reflect the information presented. Additional revisions reflect how IPL is recording SO<sub>2</sub> allowances to account for IPL's purchase commitments for years 2015 through 2017. In previous EPB filings, IPL recorded these SO<sub>2</sub> allowances under the CAIR allowance surrender scheme, however since CSAPR is now in place, the recording of allowances have been revised to reflect the surrender of Acid Rain allowances. The revised table contains several new footnotes explaining these revisions.

Please remove the incorrect pages 1, 8, and 9 of Attachment A, noted above, and replace with the Revised pages 1, 8 and 9 of Attachment A, included in this filing.
