**APPLICATION OF CITY OF IOWA CITY TO  
TERMINATE CERTIFICATE**

The City of Iowa City (“Iowa City”) states as follows:

1. On October 30, 2013, the Iowa Utilities Board (“Board”) issued an Order Granting Application and Issuing Certificate to Alliance Technologies, Inc. (“Alliance”).
2. The Certificate of Franchise Authority grants Alliance the authority to provide cable or video service for the service areas designated in said Certificate, which include Iowa City.
3. In its Statement in Support of Application filed October 3, 2013, Alliance states that it “intends to commence video service within [Iowa City] not later than February 1, 2014.”
4. Section 477A.3(1)(h) of the Iowa Code provides that the schedule described in Paragraph 3 above “shall be timely updated by the applicant as necessary to maintain accuracy.”
5. Alliance has not filed any updates on the schedule described in Paragraph 3 above.
6. Alliance has failed to commence operation of video or cable service in Iowa City.
7. Section 477A.3(6)(a) of the Iowa Code (2015) and 199 IAC 44.6(1) provide that if a certificate holder fails to commence operation of the cable or video service as proposed in its application within twelve (12) months from the date the Board granted the application, the Board may determine that the certificate holder is not in compliance with the certificate and may revoke the certificate.

8. Because Alliance has failed to commence operation of video service as proposed within twelve (12) months of October 30, 2013, the Board should determine that Alliance is not in compliance with its certificate and revoke the certificate as it applies to Iowa City.

WHEREFORE, Iowa City respectfully requests that the Board:

- A. Determine that Alliance is not in compliance in Iowa City with Certificate No. VC-0022 issued on October 30, 2013; and
- B. Revoke Certificate No. VC-0022 as it applies to Iowa City.
