APPLICATION FOR CONFIDENTIAL TREATMENT

COMES NOW, Interstate Power and Light Company (IPL), and for its request for confidential treatment pursuant to Iowa Code § 22.7(3) and (6), states as follows:

1. IPL is submitting herein for filing with the Iowa Utilities Board (Board) Second Semi-Annual Environmental Controls Project Update (Second Semi-Annual Update), in response to the Iowa Utilities Board's Order Approving Settlement and Requiring Reports (Order), issued September 24, 2014.

2. IPL is separately filing a portion of IPL's Second Semi-Annual Update that it deems to contain confidential materials in the form of a report to a government agency, which, if released, would give advantage to competitors and serve no public purpose, pursuant to the requirements of Iowa Code § 22.7(6).

3. The material subject to this request has been marked as "Confidential," in conspicuous and numerous locations upon the material, and can be found specifically in the following locations:

- Attachment A, Table1;

This document specifically contains forward looking projections related to IPL's revenue requirement, including projected capital expenditures. This information could be used by IPL's competition to gather market-sensitive information. Disclosure of such information could harm IPL's position in the competitive market to the detriment of its customers.

4. Release of the information could result in the release of commercially sensitive, trade secret information, and could result in higher costs to customers, which furthers no public purpose and therefore should remain confidential pursuant to Iowa Code § 22.7(3) and(6).

5. The confidential treatment portion is required in order to preserve the confidential nature of that material to meet the exemption requirements of Iowa Code § 22.7(3) and (6).

6. IPL is submitting an Affidavit in support of its Request for Confidentiality from a responsible corporate officer.

WHEREFORE, IPL respectfully requests that the Board grant its Request for Confidentiality, and that the Board hold confidential the portions of IPL's filing so marked.
