**ALTERNATIVE ENERGY PRODUCTION RATE  
COMPLIANCE FILING**

TF-2016-0322**

Purpose

Consistent with the Board's Order Requiring Revised Tariff in Docket Nos. TF-2016-0321 and TF-2016-0322 on February 3, 2017 (February 3<sup>rd</sup> Order), Interstate Power and Light Company (IPL) submits its Compliance filing.

In addition, the existing net metering tariff (AEP rate) will no longer be available to customers installing their own generation. Upon Board approval, this change will be effective April 1, 2017. The existing AEP rate will be closed to customers installing generation after the date. Any customer submitting a completed interconnection application prior to April 1, 2017 will be allowed to take service under the existing AEP rate. Any existing AEP rate customer may opt for the new net metering tariff; however, those customers who transition to the new net metering pilot tariff rate will be unable to transition back to the AEP rate. Therefore, the AEP tariff sheets will be marked as "Frozen" and under the General terms section the rate will state that it is frozen to existing customers at existing locations.
