ORDER RESCHEDULING ONE CONSUMER COMMENT HEARING

(Issued February 20, 2009)

On February 19, 2009, the Utilities Board (Board) issued an order approving Interstate Power and Light Company's proposed customer notice for its upcoming electric rate case and scheduling six consumer comment hearings. Because of a scheduling conflict, one of the consumer comment hearings will be rescheduled. The consumer comment hearing in Mason City, Iowa, will be moved from May 14, 2009, to May 20, 2009. The starting time and location are the same. For convenience, the Board will list all of the currently-scheduled comment hearings below. Additional comment hearings might be scheduled if circumstances warrant.

Pursuant to 199 IAC 26.9, consumer comments hearings provide an opportunity for IPL's customers to express their views regarding the upcoming electric rate case, as well as the general quality of service provided by IPL. However, persons with specific service complaints must follow the complaint procedure prescribed in 199 IAC 6.2. Individual service complaints cannot be addressed at the consumer comment hearings.

IT IS THEREFORE ORDERED:

1. Consumer comment hearings shall be held at the following locations for the purpose of receiving public comments from the general public concerning the proposed rate increase.

a. Tuesday, April 28, 2009, beginning at 5:30 p.m., at Clarke High School Auditorium, 800 North Jackson, Osceola, Iowa.

b. Thursday, April 30, 2009, beginning at 5:30 p.m., at Kirkwood Training and Outreach Service Center (KTOS), 3375 Armar Drive, Marion, Iowa.

c. Tuesday, May 12, 2009, beginning at 5:30 p.m., at St. Mary's Parish Center, 415 11th Street, Fort Madison, Iowa.

d. Wednesday, May 13, 2009, beginning at 5:30 p.m., at Ottumwa High School Auditorium, 501 East Second Street, Ottumwa, Iowa.

e. Wednesday, May 20, 2009, beginning at 5:30 p.m., at the Muse-Norris Conference Center, Room 180D, North Iowa Area Community College (NIACC), 500 College Drive, Mason City, Iowa.

f. Thursday, May 21, 2009, beginning at 5:30 p.m., at the Grand River Center, Meeting Rooms 2 and 3, 500 Bell Street, Dubuque, Iowa.
